Colonel Sherman has turned over your letter of February 25th addressed to him in regard to the formation of a benevolent association for the members of the Farmingdale Fire Department.

Pursuant to my instructions, last night Colonel Sherman called you on the telephone and informed you that the last day for introduction of special or local bills, such as would be the bill to create the Volunteer and Exempt Firemen's Benevolent Association of Farmingdale, would be today, March 7, 1939.

It is my understanding that you informed Colonel Sherman that the Farmingdale Fire Department has not actually passed any resolution in favor of such association. As explained to you by Colonel Sherman, it was my thought, keeping in mind the best interests of your Fire Department, that it would be a good idea to introduce a bill today to create the Benevolent Association for your Fire Department with the distinct understanding that my bill would not be reported out of the Judiciary Committee of the Assembly unless I received resolutions from the Farmingdale Fire Department and the proper officials of the Incorporated Village of Farmingdale.

AN ACT

To incorporate the Volunteer and Exempt Firemen's Benevo-
lent Association of Farmingdale, Nassau county, New York,
and providing for the powers and duties of such corporation
and for the payment to it of certain fire insurance premium
tax moneys

*The People of the State of New York, represented in Senate and
Assembly, do enact as follows:*

- 1 Section 1. Incorporation; membership. A membership corpora-
- 2 tion by the name of "Volunteer and Exempt Firemen's Benevo-
- 3 lent Association of Farmingdale, Nassau county, New York," is
- 4 hereby created. It shall be composed of such persons eligible to
- 5 membership therein as hereinafter provided as shall (a) notify the
- 6 secretary of the Farmingdale fire department in writing prior to
- 7 the organization meeting of such corporation hereinafter provided
- 8 for of their desire to become members, or (b) shall attend such
- 9 meeting or an adjournment thereof, or (c) shall notify the secretary
- 10 of such corporation in writing within sixty days after his election

EXPLANATION—Matter in *italics* is new; matter in brackets [] is old law to
be omitted.

1 of their desire to become members thereof, and also such persons so
2 eligible as may become members of such corporation pursuant to its
3 by-laws.

4 § 2. Persons eligible to membership. All persons who are now,
5 or have been, or who hereafter shall be volunteer members of the
6 Farmingdale fire department, or any fire engine, hook and ladder,
7 patrol, emergency rescue squad or hose company in the village of
8 Farmingdale in the town of Oyster Bay, Nassau county, New York,
9 and all persons resident in such village who have heretofore
10 acquired or who shall hereafter acquire the status of exempt volun-
11 teer firemen as defined in section two hundred of the general
12 municipal law or any other applicable law by virtue of having
13 rendered service in the Farmingdale fire department or in any of
14 the companies comprising such fire department at the time this
15 act takes effect, shall be eligible to membership therein, except
16 that any fireman who has been removed for cause, expelled or
17 dropped from the rolls of any fire company or department shall
18 not be eligible to membership in this corporation.

19 § 3. Purposes. The purposes of such corporation shall be the
20 relief, aid and assistance of disabled or indigent members and their
21 families, the maintenance of suitable headquarters for the members
22 of such corporation, and the promotion of the volunteer fire service
23 within the area protected by Farmingdale fire department.

24 § 4. Powers and duties. Such corporation shall have all of the
25 powers of a membership corporation, and the provisions of law
26 relating to membership corporations shall apply to such corporation
27 except where they conflict with the provisions of this act. Such

1 corporation shall have the power to acquire by gift, devise or
2 bequest real and personal property for its corporate purposes. The
3 Farmingdale fire department or any company thereof may convey
4 and transfer, with or without consideration, to such corporation
5 any real estate, moneys, or other personal property now or here-
6 after owned by it upon the vote of two-thirds of the members of the
7 Farmingdale fire department or any company thereof, as the case
8 may be, present at any special meeting duly called by it for such
9 purpose.

10 § 5. Organization meeting; by-laws. The secretary of the Farm-
11 ingdale fire department shall call a meeting for the organization
12 of such corporation to be held not later than sixty days after this
13 act takes effect, notice of which shall be given by him by posting or
14 causing to be posted a notice thereof in five conspicuous places
15 within the village of Farmingdale, and also by publication of notice
16 thereof in one or more newspapers having a general circulation
17 within such territory, and such posting and publication shall be
18 effected at least ten days prior to the date of such meeting. At
19 such meeting or any adjournment thereof the members of such
20 corporation present shall adopt by-laws and elect officers and
21 trustees to serve until the first annual meeting, which shall be held
22 on a date to be fixed by the by-laws. Any member failing to comply
23 with the by-laws, rules or regulations duly adopted by such cor-
24 poration shall be subject to suspension and expulsion in such man-
25 ner as may be provided for in such by-laws. Any member who
26 ceases to be such, voluntarily or otherwise, shall forfeit all interest

1 in the property of such corporation and all rights to which he
2 might otherwise be entitled.

3 § 6. Management and control. The control and disposal of the
4 funds, property and estate of the said association, the exercise of
5 its powers and the management and control of its affairs shall be
6 vested in and exercised by a board of trustees which shall consist
7 of nine members of such corporation, to wit: the president, the vice-
8 president, the secretary, the financial secretary, the treasurer and
9 four other members having the title of trustee. Such officers and
10 trustees shall be elected at the annual meeting of such corporation
11 in the manner prescribed by its by-laws.

12 § 7. Precept for payment of foreign fire insurance premium
13 taxes. Such corporation shall collect and there shall be paid to it
14 all tax imposed by section one hundred thirty-three of the insurance
15 law, for fire department use and benefit, upon premiums for insur-
16 ance against loss or damage by fire covering property situated
17 within the village of Farmingdale, in the town of Oyster Bay,
18 Nassau county, New York, and within any duly organized territory
19 in which the Farmingdale fire department may be obligated to
20 render fire protection. The officer of said corporation designated by
21 its by-laws to collect and receive the aforesaid tax shall have the
22 same powers as provided by law for the treasurer of a fire depart-
23 ment with respect to such collection and receipt. Such corpora-
24 tion shall also be entitled to receive a share of the tax imposed by
25 section one hundred forty-nine-a of the insurance law, based upon
26 the business written in the territory with respect to which it is
27 entitled to collect and receive the tax under section one hundred

1 thirty-three of the insurance law. Such taxes shall only be used for
2 the care and relief of disabled or indigent volunteer and exempt
3 firemen and their families.

4 § 8. Time to take effect. This act shall take effect immediately.
